Directory Brief:

This VAW and GBV services directory holds pertinent contact information for women migrant workers in need of protective and social welfare services. Although some organizations specifically cater to migrant needs, it is important to note that a great amount of the information in this directory is meant for general needs of in-distress women in the Philippines, specifically GBV survivors.

The information is segmented into specific categories: Health, Police and Justice, Social Welfare, and Consulates/Embassies in countries of destination. Services for women migrant workers are divided into two: ""migrant-focused"" and ""general GBV"".

- Agencies which provide only ""migrant-focused"" services mean that their mandates are (or they
 were established) specifically to address overseas migrants' issues, although not necessarily focused
 on GBV or catering solely to women migrant workers.
- Agencies which provide only ""general GBV"" services mean that they provide services for GBV survivors, regardless of whether they are overseas labor migrants or not. The scope of their services is limited to women who are in the Philippines.
- Agencies which provide both ""migrant-focused"" and ""general GBV"" services mean that they
 have specific welfare programs and interventions for women migrant workers (not necessarily only
 on GBV), as well as for GBV survivors.

Health

Health information stipulated in this directory range from mental/psychosocial to physical- both emergency and non-emergency services. There are national agencies/hospitals (usually situated in Metro Manila), while it is important to highlight that almost all of the regional/provincial health facilities listed in the directory have a corresponding VAWC (Violence against Women and Children) desk accompanied by social workers and police personnel, thereby creating a more holistic range of services (enjoining the second and third category- police & justice and social welfare accordingly).

Police and Justice

Police and Justice Services are mostly centralized. Most of the regional numbers are tied with local government offices or local police units. For instances like trafficking for example, cases are still elevated to national agencies that's why there is an assigned emergency hotline for such. These services also assist in the legal aspect of achieving justice for the distressed women migrant worker.

Social Welfare

The Social Welfare agencies mentioned here (both government and non-government) offer a wide array of services--- from assistance in times of distress at the country-of-destination (counseling, financial support, repatriation assistance) to reintegration and rehabilitation services upon return (livelihood, capacity-building training, scholarships, etc.).

Most of the regional/provincial organizations in the list do not specifically cater to women migrant workers, but would nevertheless accommodate women migrant workers.

Embassies/Consulates in Countries of Destination:

The contact numbers of embassies/consulates listed in this directory is that of the ATN (Attention to Nationals) hotline service. The ATN hotline is the segment of the embassy assigned to respond to Filipino migrant workers in distress. The ATN officer will be the one assisting the distressed WMW to relevant services available within that specific embassy/consulate. The trunkline is also indicated just in case the ATN hotline is busy.

Points to Consider:

- The VAW/GBV-services that are non-migrant focused might have lapses in their knowledge of
 dealing with migrant- specific concerns/issues, albeit they are excellent entry points in acquiring
 reliable help and information (as in the case of local government/police units that can make
 referrals or elevate migrant- specific concerns to national migrant agencies like OWWA, POEA, DFA).
- The information in this directory, although manually validated, must be updated from time to time (especially local government services that are usually affiliated with incumbent government officials).

Note that all government agencies listed in this directory can make referrals across the health, police and justice, and social welfare conduit, regardless of their specific focus of services. Therefore, each agency is an entry point in accessing other relevant services.
